### IN THE FIRE – PART I "Coping with Trials" James 1:1-8

James was writing to people who were having a rough go of things. In fact, it would be fair to say they were living in crisis mode. During the covid pandemic many of us have had our fair share of challenges. Some trials are minor in nature while others may take us right to the end of our emotional and spiritual rope. James wrote to his people to give them some ways they could make sense out of trials and cope with them through God's help. The advice James gives his readers will strengthen you as you walk through your difficult times.
